1. Opening by Prof. Dr. Theo Schuyt, ERNOP President

The general assembly meeting was opened by Theo Schuyt (ERNOP President).

3. ERNOP in 2015-2016

Theo Schuyt elaborates on ERNOP in the past year, in which ERNOP was clearly visible in the academic and European policy table. Many ERNOP members celebrated the ending of the EUFORI Study and attended the final presentation in Brussel on December 14th. Also, the "Philanthropy and Social Investments Fostering Research and Innovation" (PhiSI) Conference was a success. In the past year, many of us also worked together in mapping the current state of research on Giving in Europe (GEU); we presented the first preliminary results at the annual assembly of the Donors Associations and Foundations Network in Europe (DAFNE) in May.

4. Expected ERNOP actions 2016-2017

An overview of the ERNOP actions planned for 2016-2017 was sent to all members.

5. Financial overview 2015

ERNOP Treasurer Georg von Schnurbein elaborates on the ERNOP financial accounts 2015. As known, ERNOP has a two-year cycle and is depending on the biennial conference revenues in order to operate at break-even level. A detailed report on the financial accounts was sent to all members.
