***Building Bridges in the aftermath of covid-19: Where will the Philanthropy of Today lead us Tomorrow?***

**Delegate Safety Information Briefing, as per Government Regulations in force from 22 October 2021**

**Please read the following and familiarise yourself with the safety requirements.**

**Delegate Immunity:** All delegates will be required to show valid proof of immunity (full vaccination or recovery from Covid-19 within the previous 6 months) and identity (photo ID will be necessary) at conference registration. Delegates who cannot do so will not be permitted to register. Please note that a negative PCR test or antigen test result in the absence of valid proof of immunity **will not** be sufficient. Immunity certificates will also be necessary for the gala event at Dublin Castle, visiting The Book of Kells and access to restaurants or pubs in Dublin.

**Delegate entrance and departure:** All delegates are asked to enter and depart via the allocated entrance and exit doors at the front of the UCD Sutherland School of Law, respecting the one-way systems in place. Please sanitise your hands on arrival, using the stations in the reception area.

**Toilet facilities:** Suggested toilet facilities are recommended near your meeting rooms. Delegates are asked to consider social distancing around these areas as appropriate. We recommend delegates take toilet breaks throughout the event rather than waiting for break times, to reduce queuing.

**Conference Catering:** The conference organisers will be following all guidelines set by the Government of Ireland with respect to all catering. Full details will be issued to all delegates in advance of the conference. These requirements may limit the opportunities for social networking at coffee breaks and receptions and we thank all delegates for their understanding and cooperation in this regard.

**Social Distancing:** All delegates are asked to allow appropriate distancing within the venue, in accordance with public health guidelines, particularly in public areas such as reception, moving through corridors, in the restaurant, during the coffee breaks, and where space may be limited such as public bathrooms.

**Face coverings in public areas:** The University has mandated that face coverings in the form of a face mask must be worn at all times in indoor settings (other than when eating and drinking).

Face coverings must be worn in indoor retail spaces and on public transport. It is also necessary to wear face coverings when going to and from restrooms in pubs and restaurants.

**Personal Hygiene during your stay:** Delegates are requested to regularly wash their hands, or use sanitizer when a sink is not available in line with government guidelines especially when using the restroom, sneezing, touching the face, blowing the nose, and smoking, eating, and drinking. As far as possible when paying the venue or nearby retailers for items not included in the conference, delegates should try to use card payments for the sake of good hand hygiene. Delegates should always remember to practice good respiratory hygiene (cover coughs and sneezes with a tissue, hand or elbow to prevent spreading harmful bacteria, immediately dispose of any tissues used to catch coughs and sneezes and wash your hands with warm soapy water afterwards).

**What to do if you develop symptoms at the venue:** If you feel unwell at any point, you should alert a member of the ERNOP local organisation committee immediately and then self-isolate away from other delegates. **At all times during your stay at the ERNOP Conference,** we expect all delegates to take responsibility for their own safety and the safety of others through adopting social distancing measures, face coverings, personal health and hygiene, and other precautions as necessary. These should be followed throughout all areas of the conference venue to help prevent the spread of coronavirus and support in maintaining a safe and welcoming environment for all. Please comply with the instructions of the venue staff and conference organisers and volunteers, they are given with the intention of helping you meet your responsibility towards yourself and others.
